

Avis Borough Council held their regular monthly meeting on Monday, October 5, 2020. Stover presiding with Mayor Harter and members Raab, Brooks, Gordon, Herman, Aungst and Christian present.

Motion by J. Raab to accept the minutes of the September 8, 2020 meeting, seconded by M. Herman and so carried with all Council voting in favor.

Motion by T. Gordon to pay the bills as so presented, seconded by J. Raab and so carried with all Council voting in favor.

The loan with JSSB was due in the amount of \$35,898.87 prior to the October meeting. Per a phone call to Council members it was approved to pay. A motion was made by J. Raab with a second by D. Aungst to get this payment on the records. All Council voted in favor.

Joe Waltz, a candidate running to be the 76<sup>th</sup> district state representative was present at the meeting and introduced himself. He has lived in Clinton County almost 50 years and would like to have the opportunity to go to Harrisburg and represent us.

Mayor, E. Harter, went over the September police report, attached hereto.

E. Hughes, Supervisor informed Council that Hawbaker will be doing the paving project on Thursday, Oct. 8<sup>th</sup> and Friday Oct. 9<sup>th</sup>. The streets getting paved are Cliff to Smith, Fairview Street unto Cliff to Clinton and behind the post office.

Jody Frantz from the Horizon Credit Union was present at the meeting. She is involved in the Community Leadership Program sponsored by the Clinton County Economic Partnership and wanted to introduce herself. She is also a resident of the Borough.

D. Aungst discussed a request that he received from Sylvan Avenue regarding having a community block party for Halloween. After discussion with Council, it was decided that although it is a very good idea, there is not enough time to get this all together for this year. It was suggested that she could perhaps talk to the fire company and maybe be able to do something there. The street committee will get together and come up with a plan for future requests like this.

The sanitary sewer report had 4 residences on the list for shut off due to being behind in sewer payments. However, due to COVID water cannot get shut off at this time.

A. Brooks stated that the benches have been delivered for the doggie park. E. Hughes will get them installed whenever his schedule will allow. She also provided signs to be put up at the post office regarding leaf pick up times and dates. She also said that the shooting club would be shooting every other week thru the middle of November and then depending on COVID will decide how they will shoot the second half of the season. The only people coming into the building will be the shooting team that uses this as their "home". Halloween hours will be the 31<sup>st</sup> from 6-8.

M. Herman stated that the ball team will be cleaning up the field and that they are done using it until the Spring.

A budget work session was scheduled for Monday, October 12, 2020. Secretary will let the accountant know about this meeting.
